## Enrollment Options

**Pre-Pay Option:** Pet owners complete the Happy Tails application and create an adoption file for each pet. The required donation is \$1,500 per cat and \$2,000 per dog.

**Deferred Payment Option:** Pet owners with life insurance or estate plans can defer payment by setting up their estate to distribute funds upon their passing. An attorney must manage the distribution, and a copy of the policy or estate plan naming HSNCF must be on file. The required donation is \$2,000 per cat and \$2,500 per dog.

**Important Notes:** Fees are non-refundable. If a covered pet passes away, members may add a new pet by completing a new adoption packet. To ensure coverage, a Happy Tails file must be created for the new pet.

## General Requirements for Enrollment in the Happy Tails Program

- **Adoptability:** Pets must meet HSNCF's adoptability criteria at the time they enter the program. Aggressive, feral, or terminally ill animals are not considered adoptable. Terminally ill animals will be placed in the **Hospice Foster Program** and provided palliative care.
- **Temperament Testing:** An HSNCF staff member will assess the pet's temperament when entering the program.
- **Household Limitations:** A maximum of 10 cats or 5 dogs per household may be accepted without prior approval.
- **Documentation:** Pet owners must provide a photo of the pet with the completed adoption packet.
- **Eligible Animals:** Currently, only cats and dogs are eligible for placement in the program.
- **Spousal Consent:** If the pet owner is married, the spouse must sign a consent form allowing HSNCF to place the pet upon the owner's death or disability.
- **End-of-Life Decisions:** Participants agree that if a pet becomes terminally ill and cannot be kept comfortable with palliative care, HSNCF has the right to humanely euthanize the pet to prevent suffering, based on the recommendation of a licensed veterinarian.
- **Notification Requirement:** Participants must arrange for HSNCF to be notified of their passing or incapacitation through a designated family member, friend, estate attorney, or hospice worker. Timely notification is essential.

## Program Guarantee

The Humane Society of North Central Florida (HSNCF) guarantees to accept any dog or cat enrolled in the Happy Tails Program that meets the adoption criteria. Each pet will remain in HSNCF's care until a suitable, permanent home is found. HSNCF will not euthanize any pet unless health or behavior issues make the animal unsuitable for public adoption.
